Polymers and polymeric preparations, i.e. the mentioned above products, pursuant to Article 2(7) of the “Regulation on Registration, Evaluation, Authorization and Restriction of Chemicals published in the Official Journal numbered 30105 on June 23, 2017” of the Turkish Republic (referred to as “KKDIK”) are exempt from the provisions on registration of the Second Part of KKDIK. Therefore, our polymeric products do not have to be pre-registered and pre-registration numbers shall not be assigned.

We hereby confirm that according to Article 7(3) of KKDIK all monomers forming the polymeric products in an amount of  $\geq 2\%$  weight by weight and in total quantities one tonne or more per year, as well as all additives used in the formulations have been pre-registered or exempted from the registration requirements.
