Dear Customer,

Polymers and polymeric preparations, i.e. the mentioned above product, pursuant to article Article 2(9) of the Regulation (EC) No 1907/2006 of the European Parliament and of the Council on the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) are exempt from the provisions on registration of Title II of REACH. Therefore, our polymeric product does not have to be registered and a registration number shall not be assigned.

We hereby confirm that according to Article 6(3) of REACH all monomers forming the polymeric product in an amount of $\geq 2\%$ weight by weight and in total quantities one tonne or more per year, as well as all additives used in the formulations have been registered or exempted from the registration requirements.
